

DEED OF CHANGE OF TRUSTEES

Important notes

- This deed is for you, as a Guardian policyholder, to use with the guidance of your financial or legal adviser if you've put your protection policy in trust using a Guardian discretionary split trust.
- The deed allows you, the settlor, to make changes to your trustees. (The settlor is the person who created the original trust over their policy.)
- Your trustees are needed if you die, to take charge of claiming and distributing any payout under the policy, in line with the terms of the trust. The beneficiaries you state can be changed by you during your lifetime, or by your trustees after your death if there are at least two of them.
- Also, your trustee(s) can sign for you if you're no longer able to do so yourself to claim any payout you're entitled to while you're alive.
- We've taken every care over the content and notes to this deed based on our understanding of current law and HMRC practice, which can change.
- We accept no responsibility for making sure it meets your needs, for the results of its use or how you complete it.
- You'll need to check with your Financial Adviser or a solicitor if you're unsure about its effect or suitability for you.

We're not bound to act according to the changes made by this deed unless and until a copy of it has been sent to us.
